Course overview

Empower the Mid-Career surgeon to enhance their safe and efficacious management of HPB patients:

- Understand and optimize patient selection, practice management, OR efficiency, and optimal patient quality outcomes
- These goals and outcomes will be defined by the attendee through close communication and interview to ensure success
- 3) Pre-program Reading and Evaluations will be required
- 4) Continued Mentor contact, case discussion, topic discussion, will occur monthly via Surgical Meetings or Web Conferencing.
- 5) At completion of the 6-month: Goals will be assessed and optimized for future development





Requirements for Participation

- 1) Mid-Career HPB Surgeon (>3 years out from last training)
- 2) Surgeon performs at least 10-20 Liver/Panc resections annually
- 3) Surgeon has performed at least 30 MIS (of any type) procedures in the last year
- 4) Surgeon expresses the desire to change current behaviors and adopt MIS for HPB procedures
- 5) Surgeon is willing to commit to the 6-month program
